CAO Records 1H 2021 Revenue of US\$8.68 billion and Net Profit of US\$24.29 million CAO 2021 年上半年收入为 86.83 亿美元,净利润达 2,429 万美元

- Revenue increased 61.60% to US\$8.68 billion due primarily to the increase in oil prices and total supply and trading volume.

- Gross profit declined 31.35% to US\$15.70 million due mainly to lower gains from trading and optimisation activities and jet fuel supply business which has not fully recovered from the impact of COVID-19 pandemic.

SINGAPORE, **30 July 2021** – China Aviation Oil (Singapore) Corporation Ltd ("CAO" or the "Group"), the largest physical jet fuel trader in the Asia Pacific region, today announced a revenue of US\$8.68 billion and a net profit of US\$24.29 million for the half year ended 30 June 2021 ("1H 2021").

Revenue for 1H 2021 revenue increased 61.60% to US\$8.68 billion from US\$5.37 billion for the half year ended 30 June 2020 ("1H 2020"), driven mainly by the increase in oil prices and total supply and trading volume.

Total supply and trading volume increased 34.80% to 17.74 million tonnes for 1H 2021, compared to 13.16 million tonnes for the corresponding period a year ago. Volume for other oil products surged 88.71% to 10.36 million tonnes in 1H 2021, primarily due to the higher trading volume for crude oil. Volume for middle distillates fell 3.78% to 7.38 million tonnes in 1H2021, of which jet fuel supply and trading volume decreased 12.24% to 4.66 million tonnes compared to 5.31 million tonnes for 1H 2020. Trading volume for gasoil increased 15.25% to 2.72 million tonnes compared to 2.36 million tonnes for 1H 2020.

2021 年上半年总业务量为 1,774 万吨, 较 2020 年上半年的 1,316 万吨总业务量增长 34.80%。其它油品业务量较上年同期激增 88.71%至 1,036 万吨,主要是因为原油业务量增加。2021 年上半年的中馏分业务量较上年同期略微减少 3.78%至 738 万吨,其中航油业务量为 466 万吨,较上年同期的 531 万吨下滑 12.24%;柴油业务量则较上年同期的 236 万吨增长 15.25%至 272 万吨。

The Group's 1H 2021 gross profit was US\$15.70 million, representing a 31.35% decrease from the corresponding period a year ago on lower gains from trading and optimisation activities as the Group's jet fuel supply business has yet to fully recover from the impact of COVID-19 pandemic.

Total share of results from CAO's associated companies jumped 313.94% to US\$16.10 million for 1H 2021, compared to US\$3.89 million for the corresponding period a year ago as share of results from the Group's key associate, Shanghai Pudong International Airport Aviation Fuel Supply Company Ltd ("SPIA") increased 584.77% from US\$2.14 million in 1H 2020 to US\$14.61 million in 1H 2021, on higher revenue and profits as a result of higher refuelling volume and oil prices.

2021 年上半年, CAO 联营公司的并帐利润较上年同期的 389 万美元增加至 1,610 万美元,增幅为 313.94%。CAO 的主要联营公司——上海浦东国际机场航空油料



有限责任公司 (以下简称"浦东航油") 的 2021 上半年投资收益较上年同期的 214 万美元跃升 584.77%至 1,461 万美元,主要因为航油加注量和油价上涨,支持浦东航油收入及盈利增加。

Consequently, the Group's net profit increased 3.04% from US\$23.57 million for 1H 2020 to US\$24.29 million for 1H 2021, due mainly to an increase in share of results from associates partially offset by the decrease in gross profit.

公司 2021 年上半年的净利润从上年同期的 2,357 万美元增加至 2,429 万美元,增幅为 3.04%,主要得益于联营公司投资收益的增加,但部分被较低的毛利抵消。

Mr Wang Yanjun, Chief Executive Officer/Executive Director of CAO, said, "As the global economy gears up for recovery from the COVID-19 pandemic, the resurgence of COVID-19 infections in many parts of the world in recent months and the uneven pace of mass vaccinations continued to have a severe impact on the pace of recovery of the global aviation industry. Nevertheless, the Group continued to deliver a resilient financial performance during this period as the Group implemented proactive measures to seize market opportunities and leverage on its competitive strengths."

CAO 首席执行官/执行董事王延军先生表示: "随着全球经济正在为新冠疫情结束后的复苏做准备,全球新冠确诊病例数量的再度反弹以及大规模疫苗接种计划步伐不均,继续严重冲击全球航空业的复苏进度。尽管如此, CAO 在这期间仍采取积极措施,致力于把握市场机遇,同时借助其竞争优势,继续交出稳健的财务表现。"

Mr Wang added, "While market conditions are expected to continue to remain challenging globally, CAO remains cautiously optimistic on its performance for the current financial year as the Group continues to navigate through this unprecedented period by implementing and executing detailed protocols across the Group's operations to strengthen operational resilience ensuring minimal disruptions to sustain business continuity. The Group will stay the course to build on its jet fuel supply and trading network complemented with trading in other oil products. The Group will also continue to focus on long-term profitability by seeking opportunities for expansion through investments in synergetic and strategic oil-related assets and businesses."

王先生补充道: "尽管全球市场预计仍充满挑战, CAO 对公司的年度业绩仍保持谨慎乐观态度,并将持续推进精细化管理进程,加强公司的运营韧性以妥善应对任何运营中断事件,极力确保业务连续性,从而度过此前所未有的特殊时期。公司也将继续专注于长期盈利能力,通过投资与油品相关业务的战略性和协同效应寻求拓展机会,拓宽航油供应及贸易网络,并辅之以其它油品贸易。"
